- GENERAL NOTES:**
- ALL EXTERIOR WALLS TO BE 2x6 STUDS AT 16" O/C TYPICAL. CONTRACTOR MAY USE 2x6 AT 24" O/C IF ALL HORIZONTAL FRAMING MEMBERS ARE STACKED OVER VERTICAL MEMBERS AND 3/8" GYP. BD. IS USED INSIDE. REGARDLESS OF FRAMING METHOD CHOSEN, ALL WALL CONSTRUCTION SHALL BE IN ACCORDANCE WITH CHAPTER 6 OF 2006 IRC CODE. INTERIOR WALLS TO BE 2x4 AT 16" O/C UNLESS NOTED OTHERWISE. ALL EXTERIOR WALLS TO RECEIVE MINIMUM R-21 INSULATION.
 - ALL PLUMBING TO CONFORM TO U.P.C. (LATEST EDITION) AND HIGHEST STANDARDS OF THE TRADE. ALL WATER LINES TO BE COPPER OR PLASTIC AND ALL SEWER LINES TO BE MIN. SCH 40 PVC. GAS LINES SHALL BE BLACK IRON PER CODE. FIXTURES SHALL BE AS SELECTED BY THE OWNER. PLUMBING CONTRACTOR TO OBTAIN ALL NECESSARY PERMITS. PLUMBER SHALL VERIFY LOCATION OF SEWER AND WATER MAINS AND MAKE SERVICE CONNECTIONS AS REQUIRED. BURIED WATER SERVICE TO BE HDPE PIPE.
 - ALL ELECTRICAL SHALL CONFORM TO N.E.C. (LATEST EDITION) AND ALL APPLICABLE STATE CODES. ALL SERVICES SHALL BE COPPER AND ALL WIRING TO BE MIN. 14-2 COPPER W/ GRD. ELEC. CONTRACTOR SHALL OBTAIN NECESSARY STATE PERMITS. FIXTURES SHALL BE AS SELECTED BY OWNER.
 - HEATING SHALL BE INSTALLED BY CERTIFIED HEATING CONTRACTOR AND SHALL BE OF TYPE SPECIFIED BY OWNER AND INSTALLED AT LOCATION SPECIFIED BY OWNER. CONTRACTOR SHALL PROVIDE A PLAN, PRIOR TO INSTALLATION, SHOWING LOCATIONS OF ALL HEAT REGISTERS AND RETURNS FOR OWNER'S APPROVAL.
 - WINDOWS TO BE OWNER SELECTED, CLAD, DOUBLE PANE HIGH PERFORMANCE. COLOR AS SELECTED BY OWNER. FRAMER TO VERIFY ROUGH OPENING DIMENSIONS OF ALL WINDOWS AND DOORS PRIOR TO START OF WORK. FLASH ALL EXTERIOR OPENINGS W/ SISAL KRAFT BUILDING FELT, TYVEK OR OTHER APPROVED MATERIAL. STANDARD HEAD HEIGHT FOR DOORS AND WINDOWS SHALL BE 6'-10" ABOVE FLOOR. WINDOWS ARE LOCATED BY DIMENSION TO CENTER.
 - CONTRACTOR SHALL VERIFY ALL CABINETRY REQUIREMENTS WITH OWNER PRIOR TO SUBMITTING BID. ALL INTERIOR MOULDINGS AND WOODWORK SHALL BE OF MATERIAL SELECTED BY OWNER. BASEBOARDS AND CASINGS SHALL BE OF THE TYPE AND SHAPE AS SELECTED BY OWNER.
 - ALL DIMENSIONS SHOWN ON THIS PLAN ARE TO FACE OF STUD OR POST UNLESS NOTED OTHERWISE.
